CASELOAD:

Adolescents, grades K - 12th. All essential functions are conducted within the framework of cognitive, physical, social, and emotional aspects of the developmental stage.

MISSION STATEMENT:

Our mission is to provide a continuum of quality services, which promote the emotional, behavioral, educational, and physical development of children, adolescents, and their families.

OVERALL PURPOSE:

This position serves as an education teacher for programs provided by The Children's Aid Home. Responsible to provide specific educational and individual learning plans for students in those programs.

ESSENTIAL FUNCTIONS: (other duties may be assigned)

- 1. Assess student competency levels and develop educational curriculum and individual lesson plans based on academic schedule provided by the school district.
- 2. Assess student progress towards objectives, expectations, and goals for the purpose of providing feedback to students, parents, management, and school administration.
- 3. Instruct group and individual instruction within established curriculum guidelines.
- 4. Prepare a variety of written materials/documentation (i.e. grades, lesson plans, correspondence with parents, students, and school administration, quizzes, attendance, exams, progress notes, etc.) for the purpose of documenting student progress and meeting mandated requirements
- 5. Collaborate with parents, school districts and management for the purpose of improving the overall quality of student outcomes, achieving established classroom objectives in support of the IEP to progress into the standard education curriculum.
- 6. Collaborate with school district and agency to provide effective sources of teaching tools (i.e. books, supplemental materials, computer equipment, etc.).
- 7. Manage student behavior and incorporate behavior management plans and techniques for instructional and disciplinary purposes that will provide an environment of learning.
- 8. Respond to emergency situations for the purpose of resolving immediate safety concerns and directing to Program Director or Candidate for resolution.
- 9. Report incidents (i.e. fights, suspected child abuse, suspected substance abuse, harassment, etc.) for the purpose of maintaining personal safety of the students, providing a positive learning environment and adhering to school district and agency policies and procedures.
- 10. Participate in a variety of meetings IEP, Staff, 9-week grading reviews with school districts, parent/teacher meetings, etc.
- 11. Participate in performance appraisal process.
- 12. Attend training, in-service, meetings and conferences as necessary and as directed to obtain hours required by The Department of Education in order to maintain teacher certifications and obtain 40 hours according to policy.

OTHER DUTIES:

Perform other related duties as assigned.

SUPERVISION RECEIVED:

Supervision is received by the Program Director and Partial Hospitalization Program.

SUPERVISION GIVEN:

Day Treatment Program and Partial Hospitalization Program Students.

WORKING CONDITIONS:

- 1. Responding to upset or angry people.
